**Chief Executive Officer's Report** – S. Humphreys updated the board on activities in the library in the preceding month including statistics and financials. Looking ahead includes hiring one student via Canada summer jobs program and four staff will attend QW Leadercast 2019: Leading healthy teams, later this week.

#### **Trenton High School partnership**

Plans for displaying student art continue as a quote for framing/hanging equipment has been received.

## Strategic Planning process: Online survey

Around 300 surveys have been received to date, online survey closes on May  $10^{th}$  but print will be available until after Frankford Riverfest on May  $18^{th}$ . Once the feedback has been compiled, the next phase of identifying strategic directions can begin.

## **Hiring of Adult Services Coordinator**

K. Richardson began April 15<sup>th</sup> as the library's new Adult Services Coordinator.

## **Public Library Month (October)**

Approval from QW Council has been received regarding a written request to proclaim October as Canadian Library Month in the City of Quinte West; and further that a Quinte West Public Library flag fly outside City Hall for the month of October, 2019.

## **RFID** update

Testing has been steady for many weeks, planning to have the gates operational at the end of May. Staff training will be done before the gates are active.

## **Financial Report**
