Chief Executive Officer's Report

S. Humphreys updated the Board on what's new in the library including:

- all City & Library staff are using a new Covid-19 screening tool that records that Staff self-screening answers.
- QWPL will offer access to Linkedin Learning; professional development courses for learning new skills/retraining etc.
- K.Richardson (Adult Services Librarian) has joined with a local group;
 Community Wellbeing Safety Action Plan whose focus includes mental health and affordable housing, to see how the library can help meet these community needs.
- The Public School Board is promoting that every kindergarten child should have a library card ensuring equal access to resources. Library promotional material will be included at kindergarten registration. March Break for schools is postponed to April accordingly; library programming will happen in April.
- The library's new Logo will launch coinciding with the new website launch (mid-April). Library cards have been ordered, Staff/Board shirt options and Book bag options are being finalized. Other promotional items are being considered, either to be made in library (buttons) or ordered in for the April launch.

Alignment with Non Union Wages and Benefits
